### Bond Overview – General Info



On May 3, 2022 voters approved a \$150M School Bond to address capital needs across the 26 buildings within the District. Bond work is planned to be completed over the course of 7 years from 2022-2028.

The funds will be used to address the following areas across the District:

- 1) Heating, Ventilating and Air Conditioning and Electrical Infrastructure Improvements
- 2) Temperature Controls Replacement
- 3) Safety and Security Enhancements
- 4) Technology and Equipment
- 5) Athletics
- 6) Site Improvements
- 7) Buses, Classroom and Staff Furniture and Equipment Replacement
- 8) Playground enhancements

These areas were identified during a 2020 Facility Needs Assessment but may change over the course of the bond based on the needs of the District.



## Inflation - Narrative



There are several factors that are affecting the budget and schedule on the WCS 2022 Bond projects. These are some of the major factors we are seeing:

#### **Marketplace**

- Uncertainty in the design/construction marketplace continues unabated.
- Manufacturing delays and long lead times continue to disrupt the normal design and bidding cycles.
- Skilled labor shortages compound the impact by driving labor costs up as well.
- Construction pricing increases of 25-30% over the last 18-20 months, along with multiple interest rate increases from the Federal Reserve, are combining to delay and/or cancel projects across the industry. This should eventually help slow the construction market down and bring costs down but we have only seen the first indications of this to date.

#### **Lead Times**

Electrical and mechanical equipment lead times continue to jeopardize completion dates. The K-12 Team is focusing on continued clear and timely communication with clients on what will and what will not be completed. Lead time issues are also affecting next years summer construction schedules and will be the main focus in September/October.


#### **Impacts**

- Higher interest rates means higher cost of capital which can be a barrier to financing projects.
- Rising construction costs are having a significant impact as budgets set even 1-2 years ago are challenging and are forcing clients to raise additional capital or refine/reduce scope.
- On the positive side as Taxable Values have stayed high, K-12 Clients are seeing shortened future bond cycles and increased earned interest income.
