The Sterling Heights Parks and Recreation Department, in cooperation with Utica Community Schools and Warren Consolidated Schools, will be offering a playground program at the schools listed below. **Children may register to attend any playground site!** Activities include Arts & Crafts, Games, Sports, Art Show, Special Events, Field Trips* and more! A college student or older Senior Leader will staff each playground, along with at least one Junior Leader and an Aide.

Please note that all staff have passed a background check and are certified in CPR, First Aid and Concussion Training.

AGES: 5-14 years old (Born between 8/3/04 and 6/20/14). **Note:** Children must be 5 years old on or before June 20, 2019 in order to register (or must wait to register until turning 5).

TIME: Monday through Friday, 9:00 a.m. to noon and 12:30 p.m. to 3:00 p.m. A staff member is present during the lunch period from noon to 12:30 p.m. Lunch is not provided (see below for exceptions) and refrigeration is not available. The playground will reopen at 12:30 p.m.

STARTS/ENDS: Thursday, June 20 to Friday, August 2, 2019. Six Weeks - no program July 4, July 5 July 25 & July 26. Sites are closed on field trip days to those not attending the trip. This is a drop-in program; daily or full day attendance is not required. Children should come prepared to take part in all activities. Please dress in gym shoes daily! Open toe shoes are not recommended for safety purposes.

FEES: RESIDENTS: \$120 per Sterling Heights resident. (Includes Camp T-Shirt**)

NON-RESIDENTS: \$176 per non-Sterling Heights resident. (Includes Camp T-Shirt**)

*Field trip fees are not included in the registration fee.
