WCS Commitment to Keeping Students Safe

In the district's continued efforts to be at the forefront of school safety, Warren Consolidated Schools held an Active Shooter Response Training session for staff at the end of August.

Active Shooter Response Training was a day-long realistic training and teaching session presented by Rick Scholz, Director of Security and Crisis Management, in partnership with the Sterling Heights and Warren Police Departments.

More than 125 employees from various cross-sections of the district participated in active shooter response training that places them in realistic scenarios in a variety of school environments, including classrooms, hallways, media centers, and cafeterias.

Participants visited a district elementary, middle, and high school to conduct the training and participate in the scenarios. At the conclusion of the training sessions, participants had an opportunity to reflect on their experience and offer feedback for continued training.

"A driving force behind the district's focus on safety comes from the Warren

Consolidated Schools Board of Education, led by President Sue Trombley and Vice-President Dr. Megan Papasian-Broadwell," Superintendent of Schools, Dr. Robert D. Livernois said. "The Board has always been proactive in its expectations for school safety."

Security cameras are located throughout the district, including school busses, with real-time access by local police departments and the county; school resource officers stationed in all three high schools; regular A.L.I.C.E. drills; all staff crisis drills; secure entrances with controlled access; and an extensive security and crisis management plan.

Earlier this year, WCS received high marks and a letter of commendation from the Macomb County Office of Emergency Management for dedicated and proactive efforts in all areas of school safety.

The Active Shooter Response Training session was made possible due to the additional funding schools received from the state budget for the 2022-23 school year, which specifically allocated money for school safety.

collaborate and implement proactive efforts in all areas of school safety. The team is committed to creating a safe and secure educational environment for all students and staff.

WCS is proactive in running safety drills such as fire, tornado, and lockdown drills several times a year. The district has implemented ALICE (Alert, Lockdown, Inform, Counter, Evacuate) drills as its Active Violence Protocol. ALICE is a nationally recognized program that utilizes best practices on how to respond to an active assailant. WCS has policies in place that require every employee to receive train-

ing, and the ALICE protocols are incorporated in active violence drills.

WCS has partnered with the Michigan Attorney General's office to implement the OK2SAY program in our district. OK2SAY provides a method of reporting where a student can anonymously report if they see or hear something that threatens a student or school safety. The

program is managed by the Attorney General's office and is available to students 24/7 through calls, emails, texts, or the mobile app.

Breakfast and lunch information for 2022-23

BREAKFAST—Warren Consolidated School Nutrition Services Department offers a variety of easy to eat nutritional breakfasts served out of the cafeteria each morning 15 minutes prior to the start of school.

The WCS school breakfast program gives hardworking parents a hand in meeting their child's nutritional needs without interrupting the school day or taking away from important learning time.

Students who routinely start their day with a good breakfast will learn healthy eating habits that will serve a lifetime.

The cost of breakfast is \$1.75 in the High Schools and Middle Schools and FREE in the Elementary Schools.

If your child qualifies for a free or reduced priced lunch, they also qualify for free or reduced priced breakfast of 30 cents.

LUNCH—All elementary school students will continue to receive FREE breakfast and lunch as part of the National School Lunch and School Breakfast Program called Community Eligibility Provision (CEP) for the 2022-23 school year.

In place of a Free and Reduced-Price Meal Application, elementary families are asked to please complete a Household Information Report at warren.familyportal.cloud. This report is critical in determining the amount of money that WCS schools receive from a variety of State and Federal supplemental programs.

Middle and High School students may qualify for free meals by completing a Free and Reduced Meal application at **warren.familyportal.cloud/guest**. A letter will be mailed to the applicant's household explaining the qualifying benefits.

Latchkey registration now open



In order to ensure that all WCS families have the opportunity to participate in quality before and after school care, students must be registered in Latchkey and families must pre-select Latchkey dates of attendance a minimum of two-weeks in advance (as space is limited). Same day registration and "Drop-In" Latchkey Services are not available.

After completing the registration process, parents will pre-select dates of attendance in advance on a first-come, first-serve basis until the attendance date(s) are full.

Registration is \$50 and must be paid in order to pre-select attendance dates. Additional information is available at **WCSKIDS.net** or by calling **586-698-4046**.

Annual Notices

Family Education Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires Warren Consolidated Schools, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Warren Consolidated Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow Warren Consolidated Schools to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish vearbooks. In addition, two federal laws require local education agencies (LEA's) receiving assistance under the Every Student Succeeds Act (ESSA) 2015 to provide military recruiters. upon request, with the following information—names, addresses and

telephone listings—unless parents have advised the LEA that they do not want their student's information disclosed without prior written consent.

If you do not want Warren Consolidated Schools to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing. Warren Consolidated Schools has designated the following information as directory information:

- Student's name
- Address
- Telephone listings
- Electronic mail address
- Photograph
- Date and place of birth
- Major field of study
- Dates of attendance
- Grade level
- Participation in officially recognized activities and sports
- Weight and height of members of athletic teams
- Degrees, honors and awards received
- The most recent educational agency/ institution attended
- Student ID number, user ID, or other unique personal identifier used to communicate in electronic systems that cannot be used to access education records without a PIN, password, etc. (A student's SSN, in whole or part, cannot be used for this purpose).

Integrated Pest Management

The State of Michigan law requires that schools that may apply pesticides on school property must provide an annual advisory to parents or guardians of students attending a facility.

Please be advised that Warren Consolidated Schools utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or to reduce an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be uti-

As required by State of Michigan law, you will receive advance notice regarding the non-emergency application of a pesticide such as an insecticide, fungicide or herbicide, other than a bait or gel formulation that is made to the school grounds or buildings during the school year. Please note that notification is not given for the infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be notified following any such application.

Advance notification of pesticide applications, other than a bait or gel formulation, will be given by at least two methods. The first method will be by posting at the main entrance to the school at least 48 hours in advance. The second method will be posting at the school's main office at least 48 hours in advance.

Please be advised that parents or guardians of children attending the school are entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least three days before the pesticide application, if they so request. If you prefer to receive the notification by first class mail, contact Kenneth Matheny at Elite Pest Management who is contracted and responsible for all inspections and pesticide procedures. Elite Pest Management can be reached at 586-294-7055. The designated district employee responsible for pesticide application procedures is Laura Mabee, Manager of Auxiliary Services (586-698-4446 Imabee@wcskids.net). Forms are also available in the main offices of each school.

Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management program and records of any pesticide application, upon request.

Asbestos Hazard Emergency Response Act

requires that each year district workers and building occupants receive notification about asbestos activities such as response actions and inspections. The purpose of this correspondence is to meet those requirements and familiarize you with the asbestos related activities that have been conducted in Warren Consolidated Schools this past year.

Management Plans-In 1998, Warren Consolidated Schools contracted with Asbestos Management Inc. to conduct inspections for asbestos containing material within all district owned buildings. This information was then compiled into Asbestos Management Plans. These Management Plans are kept in each building and are available for review. A copy of each building management plan is also located in the Educational Service Cen-

Surveillance Activities—The Asbestos Hazard Emergency Response Act (AHERA) regulation requires surveillance of the condition of AMC every six months and reinspections every three years. The periodic surveillance was conducted in January

The Environmental Protection Agency (EPA) 2021. Since the last re-inspection was done in December 2020, the next three years reinspection will be conducted in December 2023. Both of these surveillance activities will be included as part of the buildings' Management Plans.

> Asbestos Abatement—It is anticipated that Warren Consolidated Schools will need to conduct asbestos abatement within its facilities over the next year removing materials such as, but not limited to, floor tile, floor tile mastic, fire doors and fire door frames. All remaining AMC will continue to be maintained under the Operations and Maintenance Program

Any removal projects will be performed by a Michigan Licensed Asbestos Abatement Contractor and managed by Nova Environmental, Inc., the District's environmental consulting firm.
