Macomb County Education Enhancement Millage Proposal on the March 10 Ballot

On March 10, 2020, Macomb County residents will be asked to vote on a 1.9 mill, ten-year regional educational enhancement millage for all Macomb County students.

An educational enhancement millage must be proposed on a county-wide basis. If approved, the money is collected by the Intermediate School District and distributed equally to all public school

districts and charters on a per student basis. With a

regional enhancement millage, WCS would

have control over how the money is spent and tailor their programs and curricular support to best fit their student/community needs.

This millage would provide approximately \$55 million annually for all school districts in Macomb County.

Warren Consolidated Schools would receive more than \$400 per student in additional resources an investment in our students' success.

The additional funds would benefit WCS students by expanding and maintaining programs and course offerings for students; update instructional materials; invest in teachers and support staff; and protect and increase our extracurricular activities for students.

According to the 2019 Equalization Report, the average Macomb

County home is valued at close to \$200,000. The 1.9 mill Macomb County Enhancement Millage would cost approximately \$190 per year on a home valued at \$200,000 or approximately \$95 per year on a home valued at \$100.000.

"Warren Consolidated Schools has a long-standing reputation for providing quality programs, while serving as good stewards of our

> taxpayer's money," Superintendent of Schools Robert D. Livernois, Ph.D. said.

Livernois said the state has failed to fund public schools for several years. The regional educa-

tional enhancement millage gives Macomb County communities an opportunity to provide a stable source of funding that goes directly to WCS students and will attract and retain a talented workforce, Livernois said.

Strong schools and strong communities attract new businesses, support existing small businesses and bring new families to our district, creating a desirable community where people want to live and raise a family.

Register TODAY for Early Childhood and Transitional Kindergarten classes for the 2020-21 school year

WCS is proud to offer our community high-quality preschool and transitional kindergarten programs.

Beginning in March, the district will begin accepting registration for these programs which focus on kindergarten preparation.

The programs also focus on early childhood objectives for development and learning including: socialemotional, physical health, language, cognitive, literacy, mathematics, science and technology, social studies, the arts, and English Language Acquisition.

The following Early Childhood programs are available:

Transitional Kindergarten—

- FREE full-day program
- Five days per week
- For students who turn 5 and are born between September 1 and December 1, who would benefit from an additional year of growth between preschool and kindergarten, or who have limited early childhood experiences
- A program that combines academics with critical social and emotional development standards for students not quite ready for traditional kindergarten

World of Fours—

- Must meet income eligibility guidelines and be a Macomb County resident to qualify
- Half-day and full-day programs available
- Must be 4 years old on or before September 1

Tuition-based Preschool—

- 30 week program
- Classes held at Siersma, Susick, and Wilde Elementary Schools
- For students who will be 3 years of age on or before September 1; Class meets two

days per week for two hours

For students who will be 4 years of age on or before September 1; Class meets four days per week for three hours

Early Childhood Special Education—

- Special Education preschool program for children ages 3-6 with a current IEP
- Offers half-day programs and one full-day program
- Classes taught by a certified special education teacher with one paraprofessional per classroom
- Skills taught include: communication, behavior training, fine motor, gross motor, and preschool academics individualized to the student
