EL students continue to grow through daily support

As a member of the Warren Consolidated Schools Board of Education, it is an honor to serve the students, staff, and residents of this district.

In my capacity as Board Secretary, I am afforded the opportunity to participate in several district events and activities and witness the various accomplishments of the students who attend our schools.

One thing I am most proud of is the fact that Warren Consolidated Schools is made up of such a diverse population of community members. More than 70 languages are spoken in homes throughout the district, including Chaldean, Arabic, Bengali, Albanian, Polish, Hmong, Vietnamese, Spanish, and many more.

Warren Consolidated Schools currently educates 3,540 English Learner (EL) students in grades K-12, and our district falls in the top five highest populations of English Learners in the state of Michigan.

Our district is showing great improvement with our EL population and I am pleased to report that we have exited 12 percent of our students in 2018, and 13 percent of students who took the WIDA ACCESS test in 2019. This is above the state average.

Summer Bond projects completed on schedule

Bond work continued throughout the district this summer, with several buildings receiving exterior, interior, classroom, plumbing, electrical, and technology upgrades.

Upgrades at Black, Cromie, Jefferson, Siersma, Susick, and Wilde Elementary Schools included: replacing concrete around the site; replacing sinks, toilets, urinals, flooring, and faucets in the restrooms; updating building signage; replacing flooring in the corridor, media center, office, and stage; replacing classroom and gym flooring; replacing drinking fountains and adding water bottle filling stations; upgrading existing fire alarm system operating software; upgrading classroom instructional technology; replacing classroom computers; and upgrading the A/V systems.

Bond work at Cousino and Warren Mott High Schools included: upgrading exterior masonry; replacing sinks, toilets, urinals, flooring, partitions, and faucets in the restrooms; refinishing the auxiliary gym floor at Warren Mott; replacing gym wall pads, bleachers, and wrestling mats; replacing gym

lockers; replacing gym equipment; replacing window treatments; replacing drinking fountains; replacing shower towers in locker rooms; upgrading building interior lighting; replacing emergency and exit lighting; football stadium lighting upgrades; and new classroom instructional devices.

Upgrades at the Career Preparation Center included: replacing sinks, toilets, urinals, flooring, faucets, and toilet partitions in restrooms; replacing flooring in selected classrooms and office; upgrading window treatments; replacing drinking fountains and adding water bottle filling stations; replacing boiler, pipes and valves; upgrading lighting, emergency egress, exit lighting, and occupancy sensors; and new instructional devices.

The improvements were made possible through a \$134.5 million bond proposal, which was approved by voters in May 2016, to preserve the district's facilities and remain competitive as one of Macomb County's leading school districts.

The Career Preparation Center partnered with several local businesses to explore the exciting world of manufacturing and the diverse career opportunities it offers during Manufacturing Day on October 4.

More than 130 CPC students participated in the initiative that focuses on exposure to the industry to help improve the perception of the field of manufacturing, and expand the understanding of its value to the U.S. and local economies.

Students had the opportunity to visit local business partners to get first-hand exposure to viable STEM careers in areas related to manufacturing, such as, skilled trades, engineering, industrial design, information technology, and more.

"We are so thankful to the business partners who opened their doors to our students to show them the reality of modern manufacturing careers," Chief Academic Officer John Bernia said.

English Learner classes are taught throughout the district and are aligned with the Michigan Department of Education's competency-based model. Our staff and Language Acquisition Specialists support our students and schools on a daily basis. The district is committed to providing research-based instruction to support EL students' development of the English language through our multi-tiered system of support.

The district also recognizes the unique linguistic, cultural, and academic needs of its EL student population and has implemented supportive English as a Second Language (ESL) programs for adults to meet these needs. Classes began in September for students ages 20 and older, and are held at Fillmore Elementary in Sterling Heights.

On August 13, I had the privilege of attending a Back-to-School event at the Chaldean Community Foundation where staff members shared essential information with families. We also provided back packs and supplies to 220 families. I am amazed at how hard our staff members continuously work with our families to build a support system and offer tools that assist with developing oral language skills.

I thank all the district staff and families who are committed to student achievement, high expectations and strong relationships.

As a child growing up in a working-class family in St. Clair Shores, I would often hear my dad say that if you don't go to work, you don't get paid. At the time, I did not appreciate how important this was in shaping my work ethic today.

Over the summer, I took some time to review district data that shows the relationship between students' grades and their attendance in school, which is kind of like going to work and getting paid. Not surprisingly, those students who regularly attend school did far better than those who were absent. In fact, our data shows a direct relationship between grades and student attendance. It also shows how great of a job our teachers are able to do when children are in class.

I ask you to join me in making a strong commitment to getting our children to school. It is an important part of their success now and later in life.

You may also be aware that the state passed a new law earlier this year, making cyberbullying a crime. I strongly encourage you to read the WCS Student Code of Conduct,

available at WCSKIDS.NET, and discuss with your child how to use social media responsibly as the consequences have become more serious for students who cyberbully.

On a related note, this past summer we completed our 3rd phase of bond improvements across our schools. Community High Falcon Friends partnership

Community High School partnered with Maple Lane Elementary School for the newly created Falcon Friends program. Community High School students in the program visit Maple Lane twice a month throughout the year to work with diverse learners.

The students will participate in hands-on learning and then journal about their experience. At the end of the school year, students will submit a reflection essay about their experience and earn credit toward their graduation. Currently there are 34 students in the Falcon Friends program.

District partners with DIA to provide field trips to third graders



Warren Consolidated Schools and the Detroit Institute of Arts (DIA) are teaming up to provide every third grader in the district with a customized tour during a free field trip to the museum.

The tour, entitled *Shaping Identity*, focuses on literacy and social studies standards. Students will visit exhibits that highlight pieces from different groups of Indigenous people.

"For many of our students, this field trip to the DIA is their first experience in a museum," Superintendent of Schools Dr. Robert Livernois said. "The DIA is an important resource for our students because art is a tool that can be used to express beliefs, ideas, traditions and identities without using words."

During each field trip, the DIA will provide writing support and interactive activity sheets to help third-graders make connections between art and their own lives, as well as a greater understanding of the art's time period and culture. At the end of their visit, students write short stories about an object they discovered at the museum.

The visits to the museum will also help English Language Learners (ELL) improve their basic vocabulary skills. After the field trip, ELL students receive sentence starters to help them share their thoughts and ideas about their experiences.

The DIA will provide free bus transportation and admission for WCS student field trips beginning in January 2020, as part of the tri-county millage that was passed in 2012.

Legal Notice

Family Education Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires Warren Consolidated Schools, with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Warren Consolidated Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow Warren Consolidated Schools to include this type of information from your child's education records in certain school publications. Examples include:

- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs; and
- Sports activity sheets, such as for wrestling, showing weight and height of team members

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local education agencies (LEA's) receiving assistance under the *Every Student Succeeds Act (ESSA) 2015* to provide military recruiters, upon request, with the following information—names, addresses and telephone listings—unless

parents have advised the LEA that they do not want their student's information disclosed without prior written consent.

If you do not want Warren Consolidated Schools to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing. Warren Consolidated Schools has designated the following information as directory information:

- Student's name
- Address
- Telephone listings
- Electronic mail address
- Photograph
- Date and place of birth
- Major field of study
- Dates of attendance
- Grade level
- Participation in officially recognized activities and sports
- Weight and height of members of athletic teams
- Degrees, honors and awards received
- The most recent educational agency/institution attended
- Student ID number, user ID, or other unique personal identifier used to communicate in electronic systems that cannot be used to access education records without a PIN, password, etc. (A student's SSN, in whole or part, cannot be used for this purpose).

Annual Notices

Integrated Pest Management (IPM)

The State of Michigan law requires that schools that may apply pesticides on school property must provide an annual advisory to parents or guardians of students attending a facility.

Please be advised that Warren Consolidated Schools utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or to reduce an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be utilized.

As required by State of Michigan law, you will receive advance notice regarding the non-emergency application of a pesticide such as an insecticide, fungicide or herbicide, other than a bait or gel formulation that is made to the school grounds or buildings during the school year. Please note that notification is not given for the infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be notified following any such application.

Advance notification of pesticide applications, other than a bait or gel formulation, will be given by at least two methods. The first method will be by posting at the main entrance to the school. The second method will be posting at the school's main office.

Please be advised that parents or guardians of children attending the school are entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least three days before the pesticide application, if they so request. If you prefer to receive the notification by first class mail, contact Kenneth Matheny at Elite Pest Management who is contracted and responsible for all inspections and pesticide procedures. Elite Pest Management can be reached at 586-294-7055. Forms are also available in the main offices of each school.

Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management program and records of any pesticide application, upon request.

Asbestos Hazard Emergency Response Act

The Environmental Protection Agency (EPA) requires that each year district workers and building occupants receive notification about asbestos activities such as response actions and inspections. The purpose of this correspondence is to meet those requirements and familiarize you with the asbestos related activities that have been conducted in Warren Consolidated Schools this past year.

Management Plans—In 1998, Warren Consolidated Schools contracted with Asbestos Management Inc. to conduct inspections for asbestos containing material within all district owned buildings. This information was then compiled into Asbestos Management Plans. These Management Plans are kept in each building and are available for review. A copy of each building management plan is also located in the Educational Service Center.

Surveillance Activities—The Asbestos Hazard Emergency Response Act (AHERA) regulation requires surveillance of the condition of AMC every six months and re-inspections every three years. The periodic surveillance was conducted in September 2014. Since the last re-inspection was done in 2016, the next three years re-inspection will be conducted in 2019. Both of these surveillance activities will be included as part of the buildings' Management Plans.

Asbestos Abatement—It is anticipated that Warren Consolidated Schools will need to conduct asbestos abatement within its facilities over the next year removing materials such as, but not limited to, floor tile, floor tile mastic, fire doors and fire door frames. All remaining AMC will continue to be maintained under the Operations and Maintenance Program.

Any removal projects will be performed by a Michigan Licensed Asbestos Abatement Contractor and managed by Nova Environmental, Inc., the District's environmental consulting firm.
